Code Compliance Officer Sean Flanagan, presented a brief timeline for case number C22090072. There was a total of 16.5 staff hours spent on this case. Code Compliance Officer Sean Flanagan stated that the fine for case number C22090072 accrued for 356 days at \$50.00 per day with a one-time administrative fee of \$25.00 for a total fine amount of \$17,825.00.

Luz Arevalo, owner of the property was present on behalf of case number C22090072. She explained that after she purchased the property there was a bad odor in the bedroom and she later discovered that someone passed away inside the home which made her start work without a permit. She stated that she struggled to find a contractor to finish the project but once she did she worked to complete the permit process.

Motion:

Director of Finance and Administrative Services Peta-Gay Lake after hearing the testimony for case number C22090072 on the subject property, made a motion to reduce the aggregated fine (\$17,825) to a total of \$850.00 inclusive of the administrative fee. The motion was seconded by Deputy City Manager Sheila Rose.

Upon roll call, the motion passed by a 3-0 vote.
