

# CITY OF COCONUT CREEK CITY COMMISSION MINUTES

#### **CALL TO ORDER**

Mayor Tooley called the meeting to order at 7:00 p.m.

#### PRESENT UPON ROLL CALL:

Mayor Tooley asked all to rise for the Pledge of Allegiance.

Mayor Tooley explained that Governor Ron DeSantis' Executive Order 20-52, as continuously extended, and Section 252.38, Florida Statutes, authorized all local governments to waive procedures and formalities otherwise required by both state and local law as necessary to allow local governments to continue to perform public work and take whatever prudent action is necessary to ensure the health, safety, and welfare of the community. She noted that the meeting was being conducted live with a quorum physically present consistent with the Governor's Order and State law. City Attorney Pyburn explained the procedures for public participation and comment for the meeting.

### **PRESENTATIONS**

Sarah Hannah-Spurlock, representing Florida City and County Management Association, presented the City Commission and City Manager Brooks with a certificate to mark the milestone.

Police Chief Arenal read a brief statement, introducing Officer John V. Rysiejko and noted his swearing-in was delayed due to COVID-19. City Clerk Leslie Wallace May administered the oath of office to Officer Rysiejko, followed by the badge-pinning ceremony.

Assistant to the City Manager Bernadette Hughes provided a brief history of the program and

She noted that Atlantic Technical Center had the highest number of participants and won the annual trophy plus a \$500 donation to the school. She thanked the schools and recognized Broward College for the administrative support to help make the event a success.

Sustainable Development Director Scott Stoudenmire explained that items 12-15 were required resolutions in support of four City-initiated transportation surtax projects. He outlined the process briefly. Senior Project Manager Michael Righetti provided an overview of the project and its impact on improving mobility along the corridor. He responded to questions from the Commission regarding the possible design features, safety, width of the shared use path, and lighting. Deputy City Manager Sheila Rose clarified that lighting was not an eligible activity under the transportation surtax project, but the City was hoping that in the future it would be not only eligible, but be a requirement. Commissioner Welch mentioned that the issue of pedestrian lighting had come up at the Broward Metropolitan Planning Organization (MPO) meeting. Vice Mayor Rydell commended staff for being proactive.

City Clerk May stated there were no advanced public comments received for the item and no one had signed in to speak.

Upon roll call, the Resolution passed by a 5-0 vote.

Mayor Tooley stated the next meeting of the Education Advisory Board was Monday, May 17 and the new member would be sworn in at that time.

Upon roll call, the Resolution passed by a 5-0 vote.

City Manager Brooks commented on a land use plan amendment hearing for an item submitted by Waste Management to the County that the Commissioners might have been contacted about, and stated staff would be attending and reiterating previously submitted comments.

City Attorney Pyburn had no report.

# **COMMISSION COMMUNICATIONS**

Commissioner Railey commended the Coconut Creek Police Department for their response the previous day at the Wynmoor Community. She shared that six Wynmoor employees went on a fishing trip, and a beloved employee was still missing following an incident. She reported on her attendance at the Foundation for Independent Living grand opening.

Commissioner Welch shared highlights from the MPO Workshop to discuss the transportation surtax projects submitted. She highlighted the discussion on pedestrian lighting along major roads, expansion of Wiles Road from four to six lanes, and an intersection safety study for Lyons Road and Atlantic Boulevard. She had listened in to the Monarch High School Accountability Committee (SAC) meeting, and the Equity Advisor spoke up to address concerns regarding K-9 Taylor searches and suggested arranging a visit with the school's Social Justice Club to survey students about the dog. Commissioner Welch referenced the recent *Feed the Need* event and stated the organization was interested in creating food pantries and lending libraries at schools. She noted that the Dave Thomas Education Center was working with the organization to start a program. Commissioner Welch added that it was National Police Week.

Commissioner Sarbone stated the State Legislature was going to be called into Special Session to discuss and hopefully vote on the gambling compact, as well as other things. He noted that 11 years ago he had been part of a team to go to Tallahassee to discuss the issue with the Governor. He stated he had reviewed the proposed legislation and reached out to staff as well as local representatives to talk about the compact. He addressed the allocation, and stated he put forth his opinion that it was working and should not be changed. City Manager Brooks added that Coconut Creek had hired an additional lobbyist for the session to assist Ericks Consultants, Inc. to work on the issue from different angles, and had reached out to the Seminole Tribe to offer assistance.

Vice Mayor Rydell thanked staff for the efforts to open up the City's summer camp. He commented on the Copans Road project meeting, stating that he wanted to be kept updated on the bus situation and ensuring funding to build a wall or significant buffer between the road and Sawgrass Village. He asked that the City designate a "point person" for residents to communicate concerns regarding the project. He noted that a local barber shop, Invictus, had organized area businesses to conduct a ceremony honoring active military veterans on May 23. Vice Mayor Rydell asked and then received consensus that a proclamation be added to the next agenda declaring the first Friday in June as "National Gun Violence Awareness Day."

Mayor Tooley shared an update from the Broward League of Cities Board. She stated that as of the most recent Broward County Mayor's Call, the County's vaccination rate was not yet 50 percent. She explained that Broward County Mayor Steven Geller was emphatic about encouraging all people to get vaccinated. Mayor Tooley shared details of the most recent Solid Waste Working Group meeting. She thanked the City administration and staff for all they do and stated the City would not be the great city it is if not for them.
