BACKGROUND:

As part of the development of the Johnson Technology Park II project, water and wastewater infrastructure was installed. The water and wastewater infrastructure was constructed per City standards and specifications and are now being dedicated to the City. The utility easements to be transferred to the City are more particularly described in Composite Exhibit "1."

DISCUSSION:

The City is committed to ensuring continuity and expansion of utility services, as well as efficient and effective customer service. The owner, at its cost, has designed and constructed water and wastewater infrastructure to serve the Johnson Technology Park II development and to be an integral part of the City's system. These facilities were designed and constructed per City standards and are now being dedicated to the City.
