RESOLUTION NO. 2023-001

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ALLSTATE RESOURCE MANAGEMENT, INC. TO PROVIDE MAINTENANCE OF PRESERVE AREAS AND AQUATIC VEGETATION CONTROL SERVICES PURSUANT TO RFP NO. 11-09-22-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 9, 2022, the City issued Request for Proposals (RFP) No. 11-09-22-11 to contract with a professional and experienced company to provide a comprehensive maintenance program for the nineteen (19) preserve sites and thirteen (13) aquatic areas under the City's jurisdiction; and

WHEREAS, solicitations were electronically sent through the eBid system to forty-two (42) prospective vendors, and three (3) responsive proposals were received from: 1) Allstate Resource Management, Inc.; 2) DeAngelo Contracting Services, LLC; and 3) Stantec Consulting Services, Inc.; and

WHEREAS, the submittals were evaluated based upon the criteria listed in the RFP by a selection committee consisting of Brian Rosen, Public Works Project Manager; John Tetteris, Public Works Superintendent; and Mike Riccio, Public Works Lead Worker; and

WHEREAS, after evaluating the submittals, the selection committee recommends awarding the contract to Allstate Resource Management, Inc. to perform the maintenance of preserve areas and aquatic vegetation control services for the City; and

WHEREAS, the initial contract period shall be for three (3) years with the option to extend for two (2) additional one (1) year periods, providing both parties agree to the extension; all terms, conditions, and specifications remain the same; and such extension is approved by the City; and

WHEREAS, the City Commission deems it to be in the best interest of the City of Coconut Creek to contract with Allstate Resource Management, Inc. to provide maintenance of preserve areas and aquatic vegetation control services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreement between the City of Coconut Creek and Allstate Resource Management, Inc. to provide maintenance of preserve areas and aquatic vegetation control services pursuant to RFP No. 11-09-22-11 and Exhibit "A," the Schedule of Proposal Prices.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the aforementioned agreement between the City of Coconut Creek and Allstate Resource Management, Inc. to provide maintenance of preserve areas and aquatic vegetation control services.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
