RESOLUTION NO. 2022-235

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED FIVE-YEAR RENEWAL OF THE INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COCONUT CREEK FOR THE USE OF THEIR TEMPORARY DEBRIS MANAGEMENT SITES IN THE EVENT OF A NATURAL DISASTER; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Broward County operates Temporary Debris Management Sites (TDMS) at various locations throughout the County for the purpose of processing debris from natural disasters; and

WHEREAS, upon execution of an Interlocal Agreement (ILA), Broward County allows its municipalities to utilize the aforementioned TDMS should they desire to do so; and

WHEREAS, Broward County and the City of Coconut Creek entered into such ILA in 2018, which is set to expire on November 30, 2022; and

WHEREAS, staff recommends renewing the ILA for the first five-year renewal period with Broward County to use their TDMS in the event the City's own sites either become unavailable and/or the quantity of disaster debris generated exceeds the capacity of the City's sites; and

WHEREAS, there is no cost to the City if the City chooses not to utilize Broward County's TDMS; and

WHEREAS, the City Commission of the City of Coconut Creek finds and determines it to be in the best interest of the City to renew the ILA for the first five-year renewal period with Broward County for the purpose of utilizing the County's TDMS should it be necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of the resolution.

<u>Section 2</u>: That the City Commission has reviewed and hereby approves the attached five-year renewal of the Interlocal Agreement between Broward County and the City of Coconut Creek for the purpose of utilizing their Temporary Debris Management Sites (TDMS) in the event of a natural disaster.

<u>Section 3</u>: That the City Manager, or designee, is hereby authorized to execute the attached five-year renewal of the Interlocal Agreement between Broward County and the City of Coconut Creek for the purpose of utilizing their Temporary Debris Management Sites (TDMS) in the event of a natural disaster.

<u>Section 4</u>: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
