# Sole-Source/Single-Source Justification

It is unlawful for a public servant, with corrupt intent to obtain a benefit for any person or to cause unlawful harm to another, to circumvent a competitive bidding process required rule by using a sole-source contract for commodities or service. Florida Statute, Chapter 838.22

#### **Sole Source Definition:**

A source selected for the purchase of goods or service over \$3,000.00 when there are no other sources capable of providing the goods of services except for the one selected.

#### Single Source Definition:

A source selected for the purchase of goods or service over \$3,000.00 due to the compatibility of equipment, replacement parts, training, warranty, or some other unique purpose ¢ though other sources are available.

Sole Source/Single Source purchases of \$50,000 or more require City Commission approval.
