I am requesting a total of \$165,000 from the Federal Forfeiture Department of Justice Fund. After review by Command Staff, these items were deemed a high priority. The money will be used to purchase the following:

Federal Forfeiture Department of Justice Fund

1. New Special Weapons and Tactics (SWAT) Armored Van - \$165,000

This request complies with the provisions of the Department of Justice Guide to Equitable Sharing for State and Local Law Enforcement Agencies Agreement and Section 932.7055, Florida Statutes. Any unused funds will be returned to the respective forfeiture fund.

As of January 30, 2023, the Finance Department's fund reconciliation showed \$332,120 in the Federal Forfeiture Department of Justice fund to cover this request of which, \$150,000 was previously earmarked for the SWAT Van. I am requesting \$165,000 for the item due to an increase in cost since the funds were originally earmarked.



Transparent Armor (Glass):

- All transparent armor provided by Tier 1 Certified and approved suppliers. The proper thickness will be sized based on the desired Ballistic and blast preference outlined in NIJ III Armor Level. Clad-Polycarbonate-Mylar, ceramic paint bands to assure adhesion with no de-lamination, anti-spall to protect against fragmentation, and no discoloration from UV rays. Generally 39/40mm Thick
- Ballistic steel Windshield overlap design ensures all glass stress loads evenly distributed to prevent the ballistic windshield from falling inward
- One-piece ballistic OEM In Appearance Curved windshield
- Two (2) Front door glass armored to NIJ III
- Glass in Each Rear Door, armored glass will be placed behind OEM windows which will be blacked out

Floor:
