RESOLUTION NO. 2022-246

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND FLORIDATOURS.COM, LLC TO PROVIDE CHARTER BUS TRANSPORTATION SERVICES PURSUANT TO IFB NO. 11-09-22-12; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 16, 2022, the City issued Invitation for Bids (IFB) No. 11-09-22-12 to contract with a qualified vendor to provide charter bus transportation services, which plays the critical role of ensuring that participants are transported in a safe and reliable manner; and

WHEREAS, the work consists of providing coach bus transportation for the Parks and Recreation Department's special events, summer day camp, senior center member field trips, and specialized activities; and

WHEREAS, two (2) bid submittals were received, including: 1) A Family Limousine & Coaches; and 2) FloridaTours.com, LLC; and

WHEREAS, the bid submitted by A Family Limousine & Coaches was determined to be non-responsive due to not submitting the required documents; and

WHEREAS, after reviewing the remaining bid, Lenore Thomas, Parks and Recreation Superintendent, and Melissa See, Parks and Recreation Superisor, determined that FloridaTours.com, LLC submitted a responsive and responsible bid; and

WHEREAS, the initial contract period will begin following approval of this resolution and full execution of the agreement, attached hereto as Exhibit "1," and will expire three (3) years from that date; however, the City may extend the contract for two (2) additional one (1) year periods, providing each party agrees to the extension under the same terms, conditions, and specifications; and

WHEREAS, the City Commission finds and determines it to be the best interest of the City to enter into an agreement with FloridaTours.com, LLC for charter bus transportation services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. The agreement, identified as Exhibit "1," attached hereto is incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreement, attached hereto and made a part hereof as Exhibit "1," between the City of Coconut Creek and FloridaTours.com, LLC for charter bus transportation services pursuant to IFB No. 11-09-22-12.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the agreement, attached hereto and made a part hereof as Exhibit "1," between the City of Coconut Creek and FloridaTours.com, LLC.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
