## FIRST AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COCONUT CREEK FOR INSTALLATION AND MAINTENANCE OF BUS SHELTERS

This First Amendment to the Agreement (the "First Amendment") between Broward County, a political subdivision of the State of Florida (the "County"), and the City Coconut Creek, a municipal corporation located in Broward County, Florida, organized and existing under the laws of the state of Florida (the "Municipality") (collectively the "Parties").

#### **RECITALS**

- A. The Parties entered into an Agreement dated August 27, 2013, ("Agreement"), which provided for the installation and maintenance of Bus Shelters within the jurisdictional limits of the Municipality.
- B. The County plans to install Bus Shelters in twenty (20) additional locations within the Municipality.
- C. The Parties desire to enter this First Amendment to include the additional Bus Shelters in the Agreement.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

- 1. Except as expressly modified herein, all terms and conditions of the Agreement remain in full force and effect. Amendments made to the Agreement by this First Amendment are indicated by use of strikethroughs to indicate deletions and underlining to indicate additions. Terms used herein but not defined herein shall have the meaning ascribed to such terms in the Agreement.
- 2. Exhibit A is hereby amended as indicated in the attached Exhibit A.
- 3. The effective date of this First Amendment shall be the date of complete execution by both Parties. This First Amendment, together with the Agreement, represents the final and complete understanding of the Parties regarding the subject matter of the items addressed herein, and together with the Agreement, supersedes all prior and contemporaneous negotiations and discussions regarding that subject matter. There is no commitment, agreement, or understanding concerning the subject matter of this First Amendment that is not contained in this written document or the Agreement.
- 4. This First Amendment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.

5. Each individual executing this First Amendment on behalf of a party hereto hereby represents and warrants that he or she is, on the date he or she signs this First Amendment, duly authorized by all necessary and appropriate action to execute this First Amendment on behalf of such party and does so with full legal authority.
