

**RESOLUTION NO. 2022-018**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, SUPPORTING THE APPLICATION FOR FUNDING FROM THE BROWARD METROPOLITAN PLANNING ORGANIZATION (MPO) 2022 MOBILITY HUB PROGRAM TO CONDUCT A MOBILITY HUB MASTER PLAN STUDY IN THE GENERAL VICINITY OF THE MAINSTREET DEVELOPMENT AREA; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek (“City”) supports enhancing existing transit infrastructure; and

**WHEREAS**, the City intends to apply to the Broward Metropolitan Planning Organization (MPO) to fund a Mobility Hub Master Plan study for the area in the vicinity of the MainStreet development area; and

**WHEREAS**, the MainStreet development area offers a Mobility Hub location with transit activity and land uses that generate transit ridership; and

**WHEREAS**, this Mobility Hub Master Plan is the initial step to implement the Mobility Hub concept in Coconut Creek, which will help to improve mobility within Broward County; and

**WHEREAS**, a resolution of support from the City of Coconut City Commission for the project is required to establish program eligibility; and

**WHEREAS**, through the MPO’s competitive funding process, the MPO will fund the full cost of the Mobility Hub Master Plan Study if the application is approved; and

**WHEREAS**, the MPO staff will serve as the project manager for the study in conjunction with City staff; and

**WHEREAS**, the City of Coconut Creek, at its sole expense, shall provide staff to

participate in the project; and

**WHEREAS**, the parties agree that local stakeholder and community input is essential for the successful completion of the study and agree to conduct outreach; and

**WHEREAS**, the parties acknowledge the commitment to pursue implementation of projects and recommendations from the study.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City supports the project depicted in Exhibit “A” and commits to consider funding the construction improvements to be constructed within Coconut Creek’s right-of-way or to pursue a public/private partnership with the development team associated with the MainStreet redevelopment.

**Section 3:** That the City endorses the MPO to deliver the projects within the City or the Florida Department of Transportation’s (FDOT) right-of-way.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
