## **RESOLUTION NO. 2022-229**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCOUNT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ZAMBELLI FIREWORKS MANUFACTURING CO. TO PROVIDE FIREWORKS DISPLAY SERVICES FOR THE BUTTERFLY FESTIVAL PURSUANT TO IFB NO. 09-20-22-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** on September 4, 2022, the City issued Invitation for Bids (IFB) No. 09-20-22-11 to contract with a qualified vendor to provide fireworks display services for the annual Butterfly Festival; and

WHEREAS, on September 20, 2022, the bids were publicly opened and three (3) bid responses were received from the following companies: 1) Starfire Corporation; 2) Zambelli Fireworks Manufacturing Co.; and 3) Pyrotecnico Fireworks, Inc. The three (3) bid responses were reviewed and determined to be responsive and responsible; and

**WHEREAS,** Staff is recommending award to the second lowest bidder, Zambelli Fireworks Manufacturing Co. as they proposed a greater quantity of fireworks displayed per dollars spent; and

**WHEREAS**, the initial term of the agreement is for three (3) years with the option to renew for two (2) additional one (1) year periods.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. The agreement, identified as Exhibit "1," attached hereto, is incorporated herein and made a specific part of this resolution.

<u>Section 2</u>: That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Zambelli Fireworks

Manufacturing Co. to provide fireworks display services pursuant to the IFB No. 09-20-22-11.

<u>Section 3</u>: That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Zambelli Fireworks Manufacturing Co. to provide fireworks display services pursuant to the IFB No. 09-20-22-11.

**Section 4**: That if any clause, section, other part or application for this resolution is held by any courts of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

<u>Section 5</u>: That this resolution shall be in full force and effect immediately upon its adoption.
