WHEREAS, the City received notification from Potter's Professional Lawn Care, Inc. that they were changing their name to Potter's Professional Lawn Care, LLC and were seeking a Consent to Assignment in accordance with the aforementioned agreement; and

WHEREAS, the terms and conditions of the agreement will remain unchanged; and

**WHEREAS,** to ensure continued and uninterrupted landscape maintenance services, staff recommends approval of the attached Consent to Assignment with Potter's Professional Lawn Care, LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK. FLORIDA:
