We herein are submitting to you our budget estimate to complete the following electrical work as requested to be performed under Contract RFP #12-05-15-16.

Supply and install:

- a) 1 Fountain Controller, including (1) 2" conduit to be ran from enclosure to lake edge for pump power cables.
- b) 1 Onetime trenching and backfilling for trenching of new electrical conduits, noted for item.
- c) 1 Metal Rack Structure to support new Fountain Control Equipment.
- d) 1 Circuit conduit with wire to be ran from existing electrical panel to location for new Fountain Control Cabinet. (Per Electrical Spec received 1/25/22)
- e) Equipment: Floating Fountain

Scope of Work:

Deliver and install one (1) Libra 750, 7.5hp, 460v, three phase lake fountains with five (5) RGB Programmable LED lights

and 250' of power cables and one (1) Libra 750, 7.5hp, 460v, three phase lake fountain with five (5) RGB Programmable

LED Lights, a single stage wind control, and 250' of power cables. Cascade Fountains will float the fountains into position

in the lake and properly moor them in place. The fountains will be ETL listed and meet or exceed all NEC and local electrical codes.

Cascade Fountains will provide UL508A Listed control panels for each of the fountains. It is the responsibility of an

electrician to mount the control panels, hot wire the controls with the proper wiring and load requirements.

Cables coming from the fountains to the controls (conduit size is determined by the size of the power cables.

Cascade Fountains will run the power cables from the fountains to the controls and terminate the wiring on the fountain side of the panels. Cascade Fountains will start the fountains, test the system and make any adjustments to the spray pattern that are necessary.

We do not include:

- a) Directional boring conduit of any kind.
- b) Permit fees and or processing.
- c) Performing any work after normal hours.
- d) Performing any work not noted.
- e) Upgrading existing panel and or associated equipment.
- f) Patching, painting, caulking of any kind.
- g) Sales Tax

- A. Purchaser acknowledges the satisfactory receipt and or completion of labor, material and services provided by Seller, in accordance with this written contract and/or oral change orders authorized by Purchaser or his agents.
- B. Additionally all amounts invoiced are due and owed to Seller upon the invoice date.
- C. Purchaser hereby waives non-receipt of any invoice as a valid defense to any of the terms and conditions of this contract.

Failure of Purchaser to pay Seller within 30 days from invoice date shall create a service charge of 1 $\frac{1}{2}$ % per month, or the highest allowable rate by law, whichever is highest, calculated from the invoice date.

If after 30 days Seller initiates collection proceedings, Purchaser and/or owner shall pay all sums invoiced, service charges plus all expenses and costs of collections, including expenses of litigation, court costs and reasonable attorney's fees, including Appellate fees to be fixed by the court, and they further agree to be sued in courts of competent jurisdiction.

Additional labor, material and services shall not be furnished by the Seller after 15 days or non-payment from invoice date. As additional consideration, Purchaser shall not have any other contractor complete the Sellers scope of work under this contract or subsequent change order. If any provision of this contract Shall, be found unenforceable, void or unconscionable that provision shall be stricken and all other provisions of this agreement shall remain in force. All suits and causes of action related to the contract shall be litigated in Broward County Florida.
