Buyer shall have 45 days from the date the Contract is executed by Buyer and Seller ("Due Diligence Period") to perform such due diligence investigations and studies, environmental testing, and feasibility analyses of the Property as Buyer deems necessary in Buyer's sole and absolute discretion and at Buyer's sole cost.
