1. CALL TO ORDER

The meeting was called to order by Chair Doug Young at 7:01 p.m.

Chair Young explained that Governor Ron DeSantis' Executive Order 20-52, as continuously extended, and Section 252.38, Florida Statutes, authorized all local governments to waive procedures and formalities otherwise required by both state and local law as necessary to allow local governments to continue to perform public work and take whatever prudent action is necessary to ensure the health, safety, and welfare of the community. He noted that the meeting was being conducted live with a quorum physical present. Sustainable Development Director Scott Stoudenmire stated that staff was proposing to repeal regulations on noise limitations contained in Chapter 13 of the Land Development Code, specifically related to sound thresholds and measuring techniques. He noted that it was brought to staff's attention that Section 13-522 conflicted with provisions in Chapter 14 of the City's Code where noise nuisance is regulated. He commented that the provisions of Section 13-522 were archaic and had not been used by the Code Enforcement division or Police Department. He stated nuisance noise issues would continue to be regulated through Chapter 14.

Chair Young opened the public hearing. Deputy City Clerk Bowers stated there were no advanced public comments received on the item, and there were no further questions or comments from the public. Chair Young closed the public hearing.
