## **RESOLUTION NO. 2016-106**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING AT LEAST EIGHT (8) BUT NO MORE THAN ELEVEN (11) MEMBERS TO THE AFFORDABLE HOUSING ADVISORY COMMITTEE PURSUANT TO SECTION 2-255 OF THE CITY OF COCONUT CREEK'S CODE OF ORDINANCES, AND IN ACCORDANCE WITH SECTION 420.9076, FLORIDA STATUTES, KNOWN AS THE STATE HOUSING INITIATIVES PARTNERSHIP ACT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
