

I subsequently interned with the City of Torrance's City Manager's office. During my internship I gained a deep appreciation for the transformative power a committed and efficient city government can have in improving the life of its residents. After completing my internship I was accepted to the University of Miami School of Law. I focused my studies on International Law.
