WHEREAS, on July 26, 2018, the alternate member resigned from the Civil Service Board, resulting in an unexpired term vacancy; and

WHEREAS, in accordance with Section 21-2.1.6 of the City's Code of Ordinances, the City Commission desires to fill the unexpired term vacancy by appointing one (1) alternate member to the Civil Service Board through the remainder of the term.
