Deputy City Manager Brooks asked for authorization for the City Manager to conduct due diligence for the potential acquisition of property located at 4651 West Hillsboro Boulevard.

## **COMMISSION COMMUNICATIONS**

Commissioner Rydell made presentations at Monarch High School and North Broward Preparatory School for Law Day held on May 1, 2019. He commented that he would be chairing a committee with the Broward County Bar Association to help educate youth on law. He spoke about the success of the Teen Political Forum and commended Mayor Welch and Assistant to the City Manager Bernadette Hughes for their work on the project.

Commissioner Tooley attended the Junior Achievement Roll Up Your Sleeves award ceremony and the Monarch High School softball game. She congratulated the softball team for their district championship and quarter regional championship. She spoke about their upcoming semi-final tournament.

Commissioner Belvedere commented that former Planning and Zoning Board Member Chick Chase thanked the City Commission for their recognition of his years of service at the April 25 City Commission Meeting. She attended the Metropolitan Planning Organization (MPO) meeting held earlier in the day where they discussed federal funds that may be available for infrastructure in Broward County. She spoke about the Arbor Day Free Tree Giveaway event held on April 27 at the Government Center and noted that she presented a proclamation for Holocaust Remembrance Day at Temple Beth Am. She thanked Public Works Project Manager Mike Heimbach for speaking to the Wynmoor Nature Club about the recent changes to the City's recycling program.

Vice Mayor Sarbone spoke about the feedback he received on the recent Advisory Board Member Orientation Workshop and commended Deputy City Attorney Kathy Mehaffey for her presentation. He attended the SOS Children's Village Annual Gala fundraising event and their community outreach breakfast and spoke about the efforts of the non-profit organization.

Mayor Welch spoke about future advisory board appointments and discussed the possibility of hosting an open house. She thanked Commissioner Rydell for his comments regarding the Teen Political Forum and spoke about the student's efforts. She asked for input to improve the forum in the future and noted that the students were holding a debriefing meeting on March 14, 2019, to discuss future improvements. She attended Monarch High School's senior award night and commented that the Women's Club of Coconut Creek provided \$15,000 in scholarship funds to graduating seniors. She attended the Women's Club of Coconut Creek Young Leaders of Tomorrow tea event.
