

**ADDENDUM TO  
AMENDMENT NO. 2 TO THE AGREEMENT BETWEEN THE CITY OF  
COCONUT CREEK AND SUNGARD PUBLIC SECTOR, LLC, RENAMED  
SUPERION, LLC FOR ONESOLUTION PUBLIC SAFETY AND  
JUSTICE/OSSI SOFTWARE LICENSE AND MAINTENANCE SERVICES**

This Addendum to Amendment No. 2 to the Agreement between the City of Coconut Creek and SunGard Public Sector, LLC for ONESolution Public Safety and Justice/OSSI Software License and Maintenance Services ("Addendum") is entered into this 14<sup>th</sup> day of February, 2019 by and between SunGard Public Sector, LLC renamed Superior, LLC (hereinafter "Contractor") the City of Coconut Creek, Florida, (hereinafter "City"), and it modifies the terms of that certain Amendment No. 2 to the Agreement between the City of Coconut Creek and SunGard Public Sector, LLC for ONESolution Public Safety and Justice/OSSI Software License and Maintenance Services. In the instance of a direct conflict with the provisions of the Amendment No. 2, the provisions of this Addendum shall prevail.

**W I T N E S S E T H:**

**WHEREAS**, Amendment No. 2 became effective December 13, 2018, however there was some clerical information that was inadvertently left off; and:

**WHEREAS**, both parties desire to amend Exhibit "B-1" to Amendment No. 2 to add the missing clerical information.

**NOW THEREFORE**, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency is hereby acknowledged, the parties hereto agree as follows:

1. Exhibit "B-1", "Add-On Quote" shall be amended to provide at the bottom of the second page as follows:
  - a. License fees are due upon execution.
  - b. Installation and configuration fees are due upon completion.
  - c. Training fees are due as incurred, billed monthly.

2. All other terms and conditions of the Agreement, Amendment No. 1 and Amendment No. 2 not in conflict with this Addendum to Amendment No. 2 shall remain in full force and effect and are incorporated herein.
