RESOLUTION NO. 2016-150

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE THE ATTACHED MUTUAL AID AGREEMENT BETWEEN THE CITY AND THE SEMINOLE TRIBE OF FLORIDA, WHICH PROVIDES FOR MUTUAL AID FOR LAW ENFORCEMENT SERVICES BETWEEN THE PARTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek and the Seminole Tribe of Florida entered into a Mutual Aid Agreement for law enforcement services on May 17, 2011, that expired on May 17, 2016; and

WHEREAS, the City of Coconut Creek and the Seminole Tribe of Florida are so close in relation to each other that it is to the advantage of both parties to extend the Mutual Aid Agreement in the way of law enforcement and resources to adequately respond to multi-jurisdictional criminal and non-criminal activities and emergencies; and

WHEREAS, the City of Coconut Creek and the Seminole Tribe of Florida believe that it is in the best interest of their citizens' health, safety, and welfare to enter into a new Mutual Aid Agreement for law enforcement services effective retroactively to May 17, 2016, for a duration of three (3) years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached Mutual Aid Agreement between the City of Coconut Creek and the Seminole Tribe of Florida.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute said Mutual Aid Agreement.
