RESOLUTION NO. 2012- 09

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING RESOLUTION NO. 2001-156, WHICH WAS AMENDED BY RESOLUTION NO. 2006-96, AND RESOLUTION NO. 2006-121, WHICH RESOLUTIONS ESTABLISHED THE SALARIES OF THE MAYOR AND COMMISSIONERS; BY INCREASING THE EXPENSE ALLOWANCE OF THE MAYOR AND CITY COMMISSIONERS; PROVIDING AN EFFECTIVE DATE

WHEREAS, Article III, Section 303 of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to periodically establish the annual salaries of its members and to establish expenses and benefits for the City Commission; and

WHEREAS, the City Commission hereby finds and determines that an adjustment in the expense allowance of the Mayor and City Commissioners is necessary; and

WHEREAS, the City Commission finds and determines that all adjustments are authorized by the provisions of Article III, Section 303 of the City Charter of the City of Coconut Creek;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That Resolution No. 2001-156, as amended by Resolution No. 2006-96 and Resolution No. 2006-121, which established the salaries, expense allowances and benefits of the Mayor and City Commission, is hereby amended as provided by the provisions of Section 2, below.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida, hereby increases the expense allowance of the Mayor and members of the City Commission to six hundred dollars (\$600.00) per month.

<u>Section 3</u>: That the City Commission of the City of Coconut Creek, Florida, finds and determines that the adjustment contained in this Resolution is authorized by Article III, Section 303, of the City Charter of the City of Coconut Creek.

Section 4: That this Resolution shall take effect February 1, 2012.
