RESOLUTION NO. 2001-156

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, RESCINDING RESOLUTION NO. 99-172; ESTABLISHING SALARIES OF THE MAYOR AND COMMISSIONERS; DECREASING THE EXPENSE ALLOWANCE OF THE MAYOR AND CITY COMMISSIONERS; PROVIDING AN AMOUNT OF MONEY FOR CAFETERIA PLAN BENEFITS FOR THE CITY COMMISSION; INCREASING THE SALARY OF THE MAYOR AND CITY COMMISSION AS OF APRIL 1, 2002; FINDING ALL ADJUSTMENTS ARE AUTHORIZED PURSUANT TO ARTICLE III, SECTION 303 OF THE CHARTER OF THE CITY OF COCONUT CREEK; PROVIDING AN EFFECTIVE DATE

WHEREAS, Article III, Section 303 of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to periodically establish the annual salaries of its members and to establish expenses and benefits for the City Commission; and

WHEREAS, the City Commission hereby finds and determines that an adjustment in the salaries, expense allowance and benefits of the Mayor and City Commissioners is necessary; and

WHEREAS, the City Commission finds and determines that all adjustments are authorized by the provisions of Article III, Section 303 of the City Charter of the City of Coconut Creek;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That Resolution No. 99-172, which raised the expense allowance of the Mayor and City Commission, is hereby rescinded in its entirety.

Section 2: That the City Commission of the City of Coconut Creek, Florida, hereby increases the salary of the Mayor to fifteen thousand two hundred dollars (\$15,200.00) per year.

Section 3: That the City Commission of the City of Coconut Creek, Florida, hereby increases the salary of the Commissioners to thirteen thousand two hundred dollars (\$13,200.00) per year.

<u>Section 4:</u> That the City Commission of the City of Coconut Creek, Florida, hereby decreases the expense allowance of the Mayor and members of the City Commission from eight hundred dollars (\$800.00) per month to two hundred dollars (\$200.00) per month.

Section 5: That the members of the City Commission are hereby allocated two thousand four hundred fifty dollars (\$2,450.00) each, payable in twenty-six (26) bi-weekly installments, to be used for benefits provided under the City's Section 125 Cafeteria Benefits program.

Section 6: That if an increase in dollars is budgeted for the Exempt Administrative Officers in any budget year for the City's Section 125 Cafeteria Benefits, the members of the City Commission shall be allocated fifty percent (50%) of any such increase in dollars.

Section 7: That effective April 1, 2002, the salary of the Mayor and the City Commission shall be increased by two thousand dollars (\$2,000.00) each.

<u>Section 8:</u> That the City Commission of the City of Coconut Creek, Florida, finds and determines that the adjustments contained in this Resolution are authorized by Article III, Section 303 of the City Charter of the City of Coconut Creek.

Section 9: That this Resolution shall take effect October 1, 2001.
