RESOLUTION NO. 2020-101

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPROVING THE AMENDED AWARD AMOUNT FOR THE BUTTONWOOD HAMMOCK HOMEOWNERS ASSOCIATION, INC. APPLICATION FOR FUNDS FROM THE NEIGHBORHOOD ENHANCEMENT GRANT PROGRAM FOR A MULTIPHASE LANDSCAPE DESIGN PROJECT TO REDESIGN THE STREET TREE MASTER PLAN; PROVIDING FOR CONDITIONS OF APPROVAL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek has funded a Neighborhood Enhancement Grant Program to provide matching funds for enhancements to the City's neighborhoods and communities; and

WHEREAS, on November 14, 2019, the City Commission awarded Buttonwood Hammock Homeowners Association \$6,250 in matching funds from the Neighborhood Enhancement Grant Program by Resolution No. 2019-261; and

WHEREAS, the Buttonwood Hammock Homeowners Association multi-phase plan consists of two phases, Phase 1 Design, and Phase 2 Installation, which is anticipated to be a future application subject to approval of the City Commission; and

WHEREAS, the Neighborhood Enhancement Grant Guidelines state that multiphase design projects and the design services associated with the project do not require a match; and

WHEREAS, Phase 1 of the Buttonwood Hammock Neighborhood Enhancement Grant Project is eligible for an additional \$6,250 in grant funding; and

WHEREAS, failure to adhere to the multi-phase street tree master plan installation plan may result in reassessment of awarded funds and code compliance actions; and

WHEREAS, Buttonwood Hammock Homeowners Association, Inc. is responsible for maintenance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission hereby approves the amended award amount from \$6,250 to \$12,500 for the multi-phase landscape design project.

<u>Section 3:</u> That Buttonwood Hammock Homeowners Association, Inc. is responsible for maintenance of the project.

<u>Section 4:</u> That failure to adhere to the multi-phase street tree master plan installation plan may result in reassessment of awarded funds.

<u>Section 5:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
