RESOLUTION NO. _ 16-300

THE CITY OF MARGATE, RESOLUTION OF FLORIDA, APPROVING AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF MARGATE, THE CITY OF COCONUT CREEK, AND THE BROWARD SHERIFF'S OFFICE FOR COOPERATIVE EMERGENCY SERVICES THROUGH AUTOMATIC AID; PROVIDING FOR INITIAL AUTOMATIC TERM; PROVIDING FOR ONE-YEAR FOR TERMINATION; PROVIDING RENEWALS; AUTHORIZING THE ADMINISTRATION TO RENEW THIS AGREEMENT UNDER THE SAME TERMS WITHOUT FURTHER COMMISSION ACTION.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

- SECTION 1: That the City Commission of the City of Margate, Florida approves the Interlocal Agreement between the City of Margate, City of Coconut Creek, and Broward Sheriff's Office for cooperative emergency services through automatic aid for an initial one-year term, four (4) one-year automatic renewals on an annual basis, and termination by either party with sixty days written notice, all as further set forth in the Interlocal Agreement attached and made a part hereof.
- SECTION 2: That the Mayor and City Manager are authorized and directed to execute the ILA on behalf of the City of Margate, a copy of which is attached and made a part of this Resolution.
- **SECTION 3**: That administration is authorized to renew the ILA under the same terms without further Commission action.
- **SECTION 4:** That this Resolution shall become effective immediately upon its passage.
