

## RESOLUTION NO. 2015 - 154

### **A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT BETWEEN THE CITY AND THE BUTLER GROUP OF SOUTH FLORIDA, LLC D/B/A NEXTAFF FOR SCHOOL CROSSING GUARD SERVICES PURSUANT TO RFP NO. 06-10-15-10; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City issued a Request for Proposals (RFP) to contract with a qualified company to provide School Crossing Guard Services at various locations in the City of Coconut Creek; and

**WHEREAS**, on May 17, 2015, the City issued eight (8) electronic invitations through the City's eBid System and received five (5) responses. The following firms submitted proposals: Kemp Group International Corporation, The Butler Group of South Florida d/b/a NEXTAFF, All City Management Services, Action Labor of FL/Staffing Connection, and LSG&P Protective Services. The proposal received from LSG&P Protective Services was determined to be nonresponsive for various compliance reasons; and

**WHEREAS**, a Selection Committee consisting of Lt. Ryan Marken, Sgt. Christopher Beroldi, and Capt. Douglas Barclay evaluated and ranked the remaining four (4) responses in accordance with the following criteria: (1) Operational Plan for the City, (2) Qualification and Experience, (3) Resources and Availability, (4) Past Performance; and (5) Price, resulting in The Butler Group of South Florida, LLC d/b/a NEXTAFF, being ranked number one; and

**WHEREAS**, the Selection Committee determined that it would be in the best interest of the City to select The Butler Group of South Florida, LLC d/b/a NEXTAFF; and

**WHEREAS**, the initial contract period will begin on August 1, 2015, for three (3) years. The City reserves the right to extend the contract for two (2) additional one (1) year periods, providing both parties agree to the extension; all the terms, conditions and specifications remain the same; and such extension is approved by the City; and

**WHEREAS**, based on the results of the reference surveys, proposed pricing, the vendor's proposal, and the evaluations performed, the Selection Committee is recommending that the City Commission approve award of the contract to The Butler Group of South Florida, LLC d/b/a NEXTAFF and the attached agreement be executed by the City Manager or designee.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the City Commission has reviewed and approves the attached agreement between the City of Coconut Creek and The Butler Group of South Florida, LLC d/b/a NEXTAFF to provide School Crossing Guard Services pursuant to RFP No. 06-10-15-10 and Exhibit "A" the Schedule of Proposal Prices.

**Section 2:** That the City Manager or designee is hereby authorized to execute the attached agreement between the City of Coconut Creek and The Butler Group of South Florida, LLC d/b/a NEXTAFF.

**Section 3:** That this Resolution shall take effect immediately upon its passage.
