


**CONSENT TO ASSIGNMENT**



**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED CONSENT TO ASSIGNMENT AND ASSUMPTION AGREEMENT IN ORDER TO PROVIDE CONSENT FOR THE ASSIGNMENT OF THE CITY'S AGREEMENT FOR ONESOLUTION PUBLIC SAFETY AND JUSTICE/OSSI SOFTWARE LICENSE AND MAINTENANCE SERVICES DATED OCTOBER 11, 2016, FROM SUNGARD PUBLIC SECTOR, LLC TO RAMUNDSEN PUBLIC SECTOR, LLC; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on October 11, 2016, the City and SunGard Public Sector, LLC entered into an agreement to provide OneSolution Public Safety and Justice/OSSI Software license and maintenance services; and

**WHEREAS**, the term of the contract commenced on October 11, 2016, and expires on September 30, 2017, with one (1) year automatic renewals thereafter unless terminated; and

**WHEREAS**, on March 7, 2017, SunGard Public Sector, LLC sold its pending contracts to Ramundsen Public Sector, LLC; and

**WHEREAS**, to ensure continued OneSolution Public Safety and Justice/OSSI Software license and maintenance services, the parties need to enter into a Consent to Assignment and Assumption Agreement with Ramundsen Public Sector, LLC, which is consistent with the SunGard Standard Terms, Paragraph 10.3. "Parties in Interest."

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**





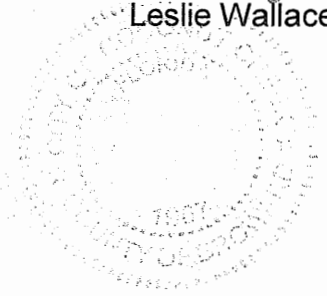
**Section 5:** That this Resolution shall be in full force and effect immediately upon its adoption.
