RESOLUTION NO. 2018-124

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH WASTE MANAGEMENT INC. OF FLORIDA FOR RECYCLABLES PROCESSING SERVICES, PIGGYBACKING THE CITY OF CORAL SPRINGS ITB 18-A-52F; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City piggybacked a Town of Southwest Ranches contract in June of 2013 for recyclables processing services provided by Sun Bergeron Solid Waste Services JV; and

WHEREAS, the above referenced contract for recyclables processing services ends July 2, 2018; and

WHEREAS, Sun Bergeron Solid Waste Services JV did not extend its recyclables processing services contract with the Town of Southwest Ranches; and

WHEREAS, the City desires to continue single stream recycling to divert materials from solid waste facilities; and

WHEREAS, the City is in need of services to process recyclables; and

WHEREAS, the City of Coral Springs has awarded a contract to Waste Management Inc. of Florida to provide recyclables processing services; and

WHEREAS, Staff recommends entering into an Agreement with Waste Management Inc. of Florida to provide the aforementioned services; and

WHEREAS, the City Commission believes it to be in the best interest of the City to execute an Agreement with Waste Management Inc. of Florida for the purpose of providing recyclables processing services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of the Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the Piggyback Agreement with Waste Management Inc. of Florida for the purpose of providing recyclables processing services for the aforementioned materials pursuant to the City of Coral Springs ITB 18-A-52F.

Section 3: That the City Manager, or designee, is hereby authorized to execute the Agreement with Waste Management Inc. of Florida for the aforementioned purpose.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
