

RESOLUTION NO. 2024-139

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND SOUTH FLORIDA UTILITIES, INC. TO PROVIDE MAINTENANCE ACCESS STRUCTURE AND WET WELL REHABILITATION SERVICES PURSUANT TO IFB NO. 05-01-24-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek (City) owns and operates more than three thousand (3,000) maintenance access structures and fifty-nine (59) lift stations; and

WHEREAS, the maintenance access structures and lift stations' wet wells collect and convey wastewater, which creates a corrosive environment and requires regular rehabilitation to provide uninterrupted wastewater services to City residents and commercial customers; and

WHEREAS, on March 31, 2024, the City issued Invitation For Bid (IFB) No. 05-01-24-11 for maintenance access structure and wet well rehabilitation services and received bids from three (3) companies, including: 1) Inter County Engineering, Inc., 2) Atlanta Pipe Services, LLC, and 3) South Florida Utilities, Inc.; and

WHEREAS, after reviewing the bids, the Purchasing Division determined that South Florida Utilities, Inc. submitted the lowest responsive and responsible bid of \$328,533.96; and

WHEREAS, the initial contract period shall be for five (5) years, beginning upon City Commission approval; and

WHEREAS, the City reserves the right to extend the contract for two (2) additional one (1) year periods, providing both parties agree to the extension; all the terms, conditions and specifications remain the same; and such extension is approved by the City; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with South Florida Utilities, Inc. to provide maintenance access structure and wet well rehabilitation services pursuant to IFB No. 05-01-24-11.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the agreement between the City of Coconut Creek and South Florida Utilities, Inc. to provide maintenance access structure and wet well rehabilitation services pursuant to IFB No. 05-01-24-11.

Section 3: That the City Manager, or designee, is hereby authorized to execute the agreement between the City of Coconut Creek and South Florida Utilities, Inc. to provide maintenance access structure and wet well rehabilitation services pursuant to IFB No. 05-01-24-11.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
