

RESOLUTION NO. 2019-219

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND TADEOS ENGINEERING, LLC TO PROVIDE FOR THE INSTALLATION OF SHADE STRUCTURES AT THE RECREATION COMPLEX AND GERBER PARK PURSUANT TO RFQ NO. 04-30-19-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, shade structures at the Recreation Complex and Gerber Park were damaged beyond repair as a result of Hurricane Irma; and

WHEREAS, the City issued Request for Qualifications (“RFQ”) No. 04-30-19-11, entitled “Design Build Park Shade Structures,” through the e-bid system for the purpose of identifying a qualified and experienced contractor to replace the damaged shade structures; and

WHEREAS, the City received two (2) responses of which one (1) was deemed to be responsive; and

WHEREAS, a selection committee consisting of Alex Tergis, Public Works Assistant Director; Lou Italice, Public Works Project Manager; and Janet Hull, Parks and Recreation Superintendent, evaluated the submittal based on the criteria listed in the RFQ; and

WHEREAS, after careful review of the RFQ submittals, including references and past experience on projects of similar scope and value, staff recommends approval of an agreement with Tadeos Engineering, LLC, the only responsible and responsive bidder, in the amount of \$199,700 for the aforementioned purpose; and

WHEREAS, the City Commission finds and determines that it is in the best interest of the City to enter into an agreement with Tadeos Engineering, LLC to provide

for the installation of shade structures at the Recreation Complex and Gerber Park in the amount of \$199,700.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Tadeos Engineering, LLC for the purpose of installing shade structures at the Recreation Complex and Gerber Park in the amount of \$199,700.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Tadeos Engineering, LLC for the aforementioned purpose.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
