

**RESOLUTION NO. 2018-295**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCOUNT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND BIG FUN, INC. TO PROVIDE AMUSEMENT RIDES AND CONCESSIONS FOR SPECIAL EVENTS PURSUANT TO RFP NO. 05-30-18-10; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City issued Request for Proposals (“RFP”) No. 05-30-18-10 to contract with a qualified vendor for amusement rides and concessions for the annual Butterfly Festival event and other special events as needed; and

**WHEREAS**, on May 6, 2018, the City issued eight (8) electronic invitations through the eBid System and received one (1) responsive submittal, which was evaluated by a selection committee comprised of Danielle DeBarros, Assistant Director of Parks and Recreation; Dwayne Vanek, Chief Electrical Inspector; and Leonardo Moleiro, Special Events Planner; and

**WHEREAS**, the proposal was based on criteria stated in the RFP document, scope of services proposed, reference checks, and performance reference surveys; and

**WHEREAS**, the selection committee ranked Big Fun, Inc. number one (1) and is recommending that they are awarded the contract for Amusement Rides and Concessions for Special Events pursuant to RFP No. 05-30-18-10; and

**WHEREAS**, the initial contract term shall be for two (2) years with the right to extend the contract for three (3) additional one (1) year periods.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Big Fun, Inc. to provide Amusement Rides and Concessions for Special Events pursuant to the RFP No. 05-30-18-10.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Big Fun, Inc.

**Section 4:** That if any clause, section, other part or application for this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
