

RESOLUTION NO. 2019-223

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING RESOLUTIONS NO. 2001-156, 2006-96, 2006-121, 2007-111, 2012-09, AND 2013-109, WHICH RESOLUTIONS ESTABLISHED THE SALARIES AND BENEFITS OF THE CITY COMMISSION TO PROVIDE THAT COMMISSIONERS SHALL BE ELIGIBLE TO RECEIVE A RETIREMENT HEALTH SAVINGS (RHS) CONTRIBUTION UPON RETIREMENT FOR CITY COMMISSIONERS WHO MEET SPECIFIC AGE AND YEARS OF SERVICE REQUIREMENTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Article III, Section 303, of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to establish the annual salaries and benefits of its members; and

WHEREAS, the City Commission wishes to establish a retiree medical compensation benefit for any commissioner who meets specified age and years of service requirements upon retirement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

Section 2: That Resolution Nos. 2001-156, 2006-96, 2006-121, 2007-111, 2012-09, and 2013-109, which established the salaries and benefits of commissioners, are hereby amended as referenced in Section 3 below.

Section 3: That the City Commission of the City of Coconut Creek, Florida, hereby establishes that City of Coconut Creek Commissioners shall be eligible for a post-retirement medical compensation benefit of two-percent (2%) of final base salary for each full year of service for City Commissioners retiring at age 55 or older with 8 or more years of service.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
