A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO RENEW THE ATTACHED BROWARD COUNTY **MULTI-AGENCY** HOMELESS OUTREACH TASKFORCE MUTUAL AID AGREEMENT WITH BROWARD COUNTY LAW **ENFORCEMENT** AGENCIES: **PROVIDING FOR** SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 23 of the Florida Statutes, "Florida Mutual Aid Act," the Coconut Creek Police Department and other Broward County agencies have the authority to enter into the Multi-Agency Homeless Outreach Taskforce; and

WHEREAS, by entering into the attached Mutual Aid Agreement ("Agreement"), the participating agencies will be able to make a coordinated effort to undertake a strategic assessment of operational capabilities to respond to homeless issues; and

WHEREAS, the Agreement will be in effect until December 31, 2028.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

- **Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.
- <u>Section 2:</u> That the City Commission has reviewed and hereby approves the Mutual Aid Agreement for the Multi-Agency Homeless Outreach Taskforce among the City of Coconut Creek and Broward County Law Enforcement Agencies.
- <u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute said Mutual Aid Agreement for the Multi-Agency Homeless Outreach Taskforce among the City of Coconut Creek and Broward County Law Enforcement Agencies.
- <u>Section 4:</u> That if any clause, section, other part, or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.
- **Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
