CALL TO ORDER

Mayor Belvedere called the meeting to order at 7:04 p.m.

PRESENT UPON ROLL CALL:

Mayor Belvedere asked all to rise for the Pledge of Allegiance led by the Coconut Creek Honor Guard. Vice Mayor Rydell wished City Attorney Pyburn a happy birthday.

PRESENTATIONS

1. 16-103 A SWEARING-IN CEREMONY FOR FIVE NEW POLICE OFFICERS: GEE BETHANCOURT, GAVIN HENRY, RICARDO PADRON, ANDREW REYNOLDS. AND NICHOLAS SCHERR.

Police Chief Arenal welcomed the new police officers and their families. He introduced each of the new Officers and asked them and their families to come forward for the badge pinning ceremony. Following the badge pinning, the Oath of Office was administered by the City Clerk.

2. 16-108 A CEREMONY RECOGNIZING THE PROMOTION OF OFFICER KEVIN VALADE TO SERGEANT.

Police Chief Arenal spoke about Police Sergeant Kevin Valade's accomplishments and invited him and his family to come forward for the badge pinning ceremony.

3. 16-119 A PROCLAMATION RECOGNIZING SEPTEMBER 21, 2016, AS "INTERNATIONAL DAY OF PEACE."

Commissioner Tooley read the Proclamation into the record.

INPUT FROM RESIDENTS OF COCONUT CREEK

Joanne Thuna, 4167 NW 22 Street, Coconut Creek, Vice President of the Pond Apple Place III Condominium Association, read an email she wrote to Utility Engineer Dennis Westrick expressing her

gratitude for staff's assistance with correcting the broken water pipe in her neighborhood. She asked if the City provides signage that advises residents to pick up dog waste, and Director of Sustainable Development Sheila Rose responded to her question.

Steve Hall, 6214 NW 45 Terrace, Coconut Creek, thanked the City Commission for their efforts regarding Waste Management's recent permit application to the Florida Department of Environmental Protection (FDEP) for a deep injection well. He mentioned a petition he started in opposition to the permit application, which already had collected 1,500 signatures. He asked the City Commission for help with educating him on the issue as he organized a movement to oppose the permit application. City Manager Blasi thanked Mr. Hall for his efforts and commented that the City Commission and City Attorney are working diligently on the issue, as well as the City's State Representative and the Broward County Commission.

City Attorney Pyburn advised that Agenda Item 10, Ordinance No. 2016-40 regarding solicitors, canvassers, and panhandlers, was pulled from the agenda and would be postponed to the September 22, 2016 City Commission Meeting in light of a recent court case involving the City of Tampa. She explained that the City needed the opportunity to review this new case prior to moving forward with the Ordinance.

Due to the implementation of the "time certain" for Consent and Regular Agenda items, the City Manager Report, City Attorney Report, and Commission Communications were heard after the Regular Agenda.

CITY MANAGER REPORT

City Manager Blasi noted that the First Budget Public Hearing would be held on September 14, 2016 at 7 p.m. following a Commission Workshop at 5 p.m.

CITY ATTORNEY REPORT

City Attorney Pyburn noted that the Commission Workshop on September 14, 2016 would include ethics training for the City Commission as well as the City Manager's annual evaluation.

COMMISSION COMMUNICATIONS

Commissioner Tooley noted that a workshop would be held on September 10, 2016 for all Broward County elected officials to discuss the One Cent Surtax referendum questions that will be on the November Ballot. She noted that she was unable to attend the FDEP hearing on Waste Management's permit application for a deep injection well because she had been out of town.

Commissioner Welch said she was disappointed with how the FDEP handled the Waste Management permit application hearing. She commended the City's staff for their efforts regarding the opening of *Career Source Broward* in their new location on the Education Corridor and noted that she had forwarded a letter from the agency thanking the staff for their assistance. She spoke about the Monarch High School Advisory Council meeting she attended and announced that a new club was started at the school called *HOPE Sunshine*, which helps students affected by suicide. She reported that Coconut Creek High School's new Magnet Program has 103 enrollees. She asked for consensus to attend the Energy Environment and Natural Resources Committee Meeting for the Florida League of Cities on October 28, 2016 in Orlando, and consensus was given.

Commissioner Sarbone spoke about the FDEP hearing and noted several changes that FDEP should make to the hearing process. He commented on recent events in the media regarding not standing during the National Anthem.

Vice Mayor Rydell asked for City Manager Blasi to meet with resident Steve Hall to educate him on the administrative process regarding Waste Management's deep injection well permit, and she agreed. He updated the Commission on his discussions with the Margate City Commission regarding the Alpha 250 site. He asked the Commission for consensus to bring forth a resolution urging the Broward County School Board to mandate that full-time nurses be provided in all Broward County public schools, and consensus was given. He commended Police Lieutenant Rob Wehmeyer, Police Sergeant Darren Karp, and Police Officer Beth Micallef for their assistance with reuniting a lost Fort Lauderdale resident with her family.

Mayor Belvedere commended the Police Department for their assistance with responding to an incident at Wynmoor earlier in the week. She commented that the Broward County Metropolitan Planning Organization (MPO) was awarded an \$11.4 million TIGER Grant by the U.S. Department of Transportation for the Complete Streets Initiative and that a celebration would be held on October 19, 2016 at 10 a.m. at the C-13 Canal in Lauderdale Lakes. She spoke about the One Cent Surtax referendum questions that will be on the November ballot. She noted that a shred-a-thon and prescription drop-off event would be held at the Community Center on September 10, 2016 at 10 a.m., and that a household hazardous waste drop-off event would be held the same day at City Hall at 9 a.m.
