RESOLUTION NO. 2025-077

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MAYOR, OR DESIGNEE, TO EXECUTE THE INTERLOCAL AGREEMENT, ATTACHED HERETO AND MADE A PART HEREOF, BETWEEN BROWARD COUNTY AND THE CITY OF COCONUT CREEK PROVIDING FOR PARTICIPATION AND FINANCIAL SUPPORT FOR THE NATURESCAPE IRRIGATION SERVICES (NIS) AND RESIDENTIAL IRRIGATION REBATE (RIR) PROGRAMS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Broward County's NatureScape Irrigation Services (NIS) program provides irrigation system inspections to identify operational efficiencies, maintenance concerns, and potential upgrades of system components to further water conservation strategies, achieve water quality improvements, and increase water savings through modifications in landscape and irrigation system design; and

WHEREAS, the City of Coconut Creek and Broward County have partnered through various Interlocal Agreements (ILA) for the NIS program since 2005, with the latest five (5) year renewal in 2020 under Resolution No. 2020-088; and

WHEREAS, this ILA contains a Residential Irrigation Rebate (RIR) program where Broward County will facilitate rebates to residents of municipalities' water service areas to offset costs incurred in upgrading water-efficient irrigation system components; and

WHEREAS, the City of Coconut Creek wishes to enter into this new ILA to identify potential water savings and best management practices along with irrigation rebates to applicants within the City's service area.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached Interlocal Agreement between Broward County and the City of Coconut Creek providing for participation and financial support for the NIS and RIR programs.

<u>Section 3:</u> That the Mayor, or designee, is hereby authorized to execute said Interlocal Agreement between Broward County and the City of Coconut Creek providing for participation and financial support for the NIS and RIR programs.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
