

**RESOLUTION NO. 2017-005**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, SETTING THE DATE FOR THE 2017 GENERAL MUNICIPAL ELECTION AS MARCH 14, 2017, FOR COMMISSION SEATS IN DISTRICTS B, C, AND E; NAMING THE POLLING PLACES; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Section 707 of the City Charter of the City of Coconut Creek, Florida, provides for calling all elections by resolution; and

**WHEREAS**, Section 301(c) of the City Charter of the City of Coconut Creek, Florida, provides for the regular City Election to be held the second Tuesday in March in years when Commissioners' terms have expired; and

**WHEREAS**, the terms of office of Commission Seats for Districts B, C, and E expire March 2017; and

**WHEREAS**, the next General Municipal Election shall be held March 14, 2017; and

**WHEREAS**, the General Municipal Election shall be conducted under those provisions of the General Election Laws of the State, when not inconsistent with the Charter; and

**WHEREAS**, the official polling places, listed by precinct number, are attached hereto and made a part hereof as Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the 2017 General Municipal Election shall be held on Tuesday, March 14, 2017, for Commission Seats in Districts B, C, and E.

**Section 2:** That the official polling places are hereby named as listed in Exhibit “A,” attached hereto and made part hereof.

**Section 3:** That the official polling places shall be open from 7 a.m. until 7 p.m. on March 14, 2017, for the purpose of having all registered voters of the City of Coconut Creek cast their ballots in the above-described election.

**Section 4:** This Resolution shall be in full force and effect immediately upon its adoption.
