## **RESOLUTION NO. 2018-029**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION FOR ENGINEERING DESIGN SERVICES TO BE PROVIDED BY R.J. BEHAR & COMPANY, INC. RELATED TO THE INSTALLATION OF PEDESTRIAN LIGHTING ON COCONUT CREEK PARKWAY; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City has determined that additional pedestrian lighting is necessary along the south side of Coconut Creek Parkway between Lyons Road and the entrance to Broward College; and

WHEREAS, the City Commission approved funding in the FY18 Capital Improvement Program to provide additional pedestrian lighting in this area; and

**WHEREAS**, engineering services are needed to design and permit these improvements; and

WHEREAS, R.J. Behar & Company, Inc. was selected and approved to be included in the City's pool of qualified consultants pursuant to RFQ No. 11-19-14-10 entitled, "General Professional Engineering Services;" and

**WHEREAS,** staff obtained a proposal from R.J. Behar & Company, Inc. to provide the aforementioned engineering design services in the amount of \$37,840; and

**WHEREAS**, staff has reviewed the proposal and considers the fees to be fair and reasonable; and

**WHEREAS,** the City Commission finds it to be in the best interest of the residents of Coconut Creek to approve a Work Authorization with R.J. Behar & Company, Inc. for the purpose of designing the aforementioned pedestrian lighting improvements on Coconut Creek Parkway.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

<u>Section 2</u>: That the City Commission has reviewed and hereby approves the Work Authorization between the City of Coconut Creek and R.J. Behar & Company, Inc. for engineering design services related to the installation of additional pedestrian lighting on Coconut Creek Parkway.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the Work Authorization between the City of Coconut Creek and R.J. Behar & Company, Inc. in the amount of \$37,840 for engineering design services related to the installation of additional pedestrian lighting on Coconut Creek Parkway.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

**Section 5**: That this Resolution shall be in full force and effect immediately upon its adoption.
