



**SECOND AMENDMENT TO AGREEMENT BETWEEN
BROWARD COUNTY AND THE CITY OF COCONUT CREEK
FOR INSTALLATION AND MAINTENANCE OF BUS SHELTERS**

This is the Second Amendment to the Agreement (the "Second Amendment") between Broward County (the "County") and the City of Coconut Creek, a municipal corporation located in Broward County, Florida, organized and existing under the laws of the state of Florida (the "Municipality") (collectively the "Parties").

RECITALS

- A. The Parties entered into an Agreement dated August 27, 2013 (the "Agreement"), that provided for the installation and maintenance of bus stop improvements within the jurisdictional limits of the Municipality.
- B. On January 15, 2020, the Parties entered into a First Amendment to include 20 (twenty) additional locations.
- C. The Parties desire to enter into this Second Amendment to provide for bus stop improvements at ten (10) additional locations.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

- 1. Except as expressly modified herein, all terms and conditions of the Agreement remain in full force and effect. Amendments made to the Agreement by this Second Amendment are indicated herein by use of strikethroughs to indicate deletions and bold/underlining to indicate additions. Terms used herein but not defined herein shall have the meaning ascribed to such terms in the Agreement.
- 2. Exhibit A is revised as indicated in the attached Exhibit A.
- 3. The effective date of this Second Amendment shall be the date of complete execution by both Parties. This Second Amendment, together with the Agreement and First Amendment, represents the final and complete understanding of the Parties regarding the subject matter of the items addressed herein, and together with the Agreement, as previously amended supersedes all prior and contemporaneous negotiations and discussions regarding that subject matter. There is no commitment, agreement, or understanding concerning the subject matter of this Second Amendment or the Agreement that is not contained in this written document or the Agreement.

4. This Second Amendment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.
5. Each individual executing this Second Amendment on behalf of a party hereto hereby represents and warrants that he or she is, on the date he or she signs this Second Amendment, duly authorized by all necessary and appropriate action to execute this Second Amendment on behalf of such party and does so with full legal authority.


