## **RESOLUTION NO. 2006-96**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING RESOLUTION NO. 2001-156, WHICH RESOLUTION ESTABLISHED THE SALARIES OF THE MAYOR AND COMMISSIONERS, BY INCREASING THE SALARIES OF THE MAYOR AND COMMISSIONERS; BY INCREASING THE EXPENSE ALLOWANCE OF THE MAYOR AND CITY COMMISSIONERS: BY INCREASING THE INSURANCE BENEFITS MAYOR OF THE COMMISSIONERS: FINDING ALL ADJUSTMENTS ARE **AUTHORIZED PURSUANT TO ARTICLE III, SECTION 303** OF THE CHARTER OF THE CITY OF COCONUT CREEK; PROVIDING AN EFFECTIVE DATE

WHEREAS, Article III, Section 303 of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to periodically establish the annual salaries of its members and to establish expenses and benefits for the City Commission; and

WHEREAS, the City Commission hereby finds and determines that an adjustment in the salaries, expense allowance and benefits of the Mayor and City Commissioners is necessary; and

WHEREAS, the City Commission finds and determines that all adjustments are authorized by the provisions of Article III, Section 303 of the City Charter of the City of Coconut Creek;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That Resolution No. 2001-156 which established the salaries, expense allowances and benefits of the Mayor and City Commission, is hereby amended as provided by the provisions of Sections 2, 3, 4 and 5, below.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida, hereby increases the salary of the Mayor to twenty-seven thousand dollars (\$27,000.00) per year.

<u>Section 3:</u> That the City Commission of the City of Coconut Creek, Florida, hereby increases the salary of the Commissioners to twenty-five thousand dollars (\$25,000.00) per year.

<u>Section 4:</u> That the City Commission of the City of Coconut Creek, Florida, hereby increases the expense allowance of the Mayor and members of the City Commission to four hundred dollars (\$400.00) per month.

Section 5: That the Mayor and members of the City Commission are hereby allocated four thousand nine hundred dollars (\$4,900.00) each, payable in twenty-six (26) bi-weekly installments, to be used for benefits provided under the City's Section 125 Cafeteria Benefits program. The Mayor and the members of the City Commission are hereby allocated 1100 flex credits, which may only be used for benefits provided under the City's Section 125 Cafeteria Benefits program.

<u>Section 6:</u> That the City Commission of the City of Coconut Creek, Florida, finds and determines that the adjustments contained in this Resolution are authorized by Article III, Section 303 of the City Charter of the City of Coconut Creek.

**Section 7:** That this Resolution shall take effect October 1, 2006.
