6. Brief Description of Event/Approximate Number of Attendees: The 10th Annual Horseshoe Hoedown takes place on the Equine-Assisted Therapies campus in the Vegso Family Arena at Tradewinds Park. The Horseshoe Hoedown serves as the signature fundraising event for this nonprofit organization helping children and adults with special needs. The riding arena, where therapeutic riding classes take place, is transformed for the evening into an open-air event venue. Guests in attendance are treated to live music from the Shane Duncan Band, gourmet buffet courtesy of A Passion for Catering, cocktail hour, dancing, games, and a silent auction, all to benefit programs like Therapeutic Riding, Hippotherapy, Equine-Facilitated Learning, and Equine-Facilitated Psychotherapy. In addition to the fun activities, there will be a short demonstration of rider skills from some of our students to illustrate the benefits of the programs. More than 250 are expected to be in attendance, including volunteers.

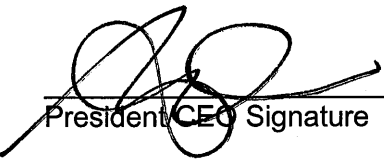
12. Percentage of Creek residents attending events: Approximately 10%
13. What is the total monetary amount requested from the City of Coconut Creek? Equine-Assisted Therapies of South Florida requests the City of Coconut Creek to consider a sponsorship in the amount of \$750 for its Horseshoe Hoedown.
14. How will the funds be used? Funds received will offset production costs associated with the event. Specifically, funds will help offset the \$2,650 expense for portable lavatories, including a handicap accessible lavatory, that is necessary due to the number of attendees.
15. What are the in-kind requests from the City of Coconut Creek? There is one in-kind request that would help keep down costs for the event, so that more proceeds can go directly into supporting programs. We engage a Coconut Creek police detail of one officer for the event. The officer is at the event for 6-7 hours. If possible, this would help save up to \$300.
16. List other funding/grants that will go toward the event (i.e. cash, in-kind services, donations, grants, etc.). The 10th Annual Horseshoe Hoedown is supported through the following:

- In addition to ticket sales and sponsorships that continue to come in supporting the event, donations during the event will account for nearly \$45,000 going directly to programs.
17. What benefits and positive effects will the City of Coconut Creek receive if a grant is awarded? The City of Coconut Creek will be listed as a sponsor of the event at the Sidewalker level. Recognition will include logo w/hyperlink on the Equine-Assisted website and inclusion on event posters and in event program. The City will also be mentioned in pre- and post-event news releases where sponsors are named. The City may also elect to submit a 1/4page ad for the event program and receive a dedicated social media posting. Residents from Coconut Creek who attend the event as volunteers or guests will see the City's involvement firsthand.
18. What percentage of the profits will go towards charity? What percentage will go towards administrative costs? 100% of the profits go toward supporting our four equine programs for children and adults with special needs.

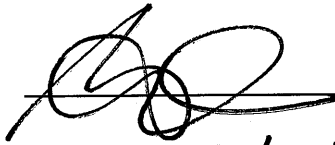
