

**RESOLUTION NO. 2020-165**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND PLAYPOWER LT FARMINGTON, INC. C/O PLAYWORX PLAYSETS, LLC TO DESIGN, FURNISH, AND INSTALL A PLAYGROUND AT SABAL PINES PARK PURSUANT TO RFP NO. 07-01-20-10; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on June 03, 2020, the City issued RFP No. 07-01-20-10 to contract with a qualified firm to design, furnish, and install a playground at Sabal Pines Park; and

**WHEREAS**, the project consists of removing an existing playground that is in poor condition and replacing it with a new castle-themed playground; and

**WHEREAS**, the City issued three hundred and seventy-six (376) electronic invitations, of which there were seven (7) responsive submittals, and a selection committee consisting of Lou Italice (Project Manager), Wayne Tobey (Parks and Recreation Director), and Phil Randazzo (Parks Superintendent) ranked the top three (3) companies based on the RFP criteria. The final ranking resulted in the following shortlist order: 1) Playpower LT Farmington, Inc. c/o Playworx Playsets, LLC; 2) Bliss Products and Services, Inc.; and 3) Playmore Recreational Products and Services (Playmore West, Inc.); and

**WHEREAS**, the negotiation committee, made up of the aforementioned staff members, negotiated an agreement for a castle-themed playground with Playpower LT Farmington, Inc. c/o Playworx Playsets, LLC in the amount of \$260,000 and a project completion time of 120 calendar days from issuance of the Notice to Proceed; and

**WHEREAS**, the Purchasing Division reviewed the RFP responses for compliance and no issues were found; and

**WHEREAS**, staff recommends approval of this agreement with Playpower LT Farmington, Inc. c/o Playworx Playsets, LLC for the purpose of designing, furnishing, and installing a playground at Sabal Pines Park; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with Playpower LT Farmington, Inc c/o Playworx Playsets, LLC to design, furnish, and install a playground at Sabal Pines Park, pursuant to RFP No. 07-01-20-10.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Playpower LT Farmington, Inc. c/o Playworx Playsets, LLC to design, furnish, and install a playground at Sabal Pines Park in the amount of \$260,000.00.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and Playpower LT Farmington, Inc. c/o Playworx Playsets, LLC and any change orders in accordance with the Purchasing Policies & Procedures Manual.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
