

RESOLUTION NO. 2019-281

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, EXPRESSING THE CITY OF COCONUT CREEK'S COMMITMENT TO ESTABLISHING POLICY TO PROMOTE A HEALTHY ENVIRONMENT WITH FOOD ACCESS AND FOOD SECURITY FOR ALL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, nutrition and environmental-related conditions such as heart disease, diabetes, and high blood pressure decrease Americans' lifespans and quality of life, leading to millions of deaths per year and leaving millions more severely ill, disadvantaged, and impaired; and

WHEREAS, lack of access to healthy food and excess of CO2 emissions are two major contributors to the development of various illnesses affecting children and families; and

WHEREAS, in 2017, over 1 in 10 South Floridians were food insecure and did not know where their next meal would come from, and 1 in 5 children in Broward County go to bed hungry each night¹; and

WHEREAS, policies that increase access to healthy foods, particularly in low-income communities and communities of color, are significantly associated with better eating habits and decreased risk for obesity and nutrition-related diseases²; and

WHEREAS, industrialized food production is one of the largest producers of CO2 emissions in the world, and working towards more local food dependence can significantly improve the environment; and

WHEREAS, policies to improve/increase healthy food access and food security can not only help with CO2 reduction, but also serve as drivers of economic growth and opportunity, engines of job creation, and often can generate social bonds among the community through mechanisms such as community gardens, promoting the economic, social, and physical welfare of all³; and

WHEREAS, this Commission wishes to eliminate food insecurity and excess CO2 and ensure that every resident in the City of Coconut Creek has access to a cleaner environment and healthy, fresh foods to build toward a future where no child need go hungry, and where all Americans have access to healthy, affordable, fresh, locally made and sustainably produced food; and

WHEREAS, the City of Coconut Creek has been actively involved in the Food for All Broward Initiative, which is focused on working with Broward County municipalities to expand access to healthy foods for residents of all ages, abilities, cultural, and economic backgrounds; and

WHEREAS, the City of Coconut Creek commits to working with the Food for All Broward Initiative and other partners to implement policy, legislative, and systems changes to help improve air quality through access to healthy foods and alternative transit opportunities and thus help prevent hunger and other nutrition-related issues; and

WHEREAS, the City of Coconut Creek Urban Design and Development Division shall consider food security and food access matters as part of its planning process for Comprehensive Plan & Community Investment Plan updates and shall incorporate food security and food access considerations wherever feasible and appropriate⁴; and

WHEREAS, the City of Coconut Creek directs the Department of Sustainable Development to recommend green policies for increasing government procurement of locally produced foods and access to healthy foods within government buildings and public institutions such as community centers, parks, greenways, and public schools.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Letter of Intent between the City and Food For All Broward.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached Letter of Intent between the City of Coconut Creek and Food For All Broward.



Letter of Intent to Increase Access to Healthy Foods

Municipal Intent to Implement Policy and Systems Changes to Benefit Local and Equitable, Healthy Food Access

Better access to healthy foods can enable residents to live healthier and more active lives, help children learn and play, contribute to a cleaner environment, and support a thriving local economy. The City of Coconut Creek participated in the [Food For All Broward](#) initiative which invited community leaders, stakeholders, and elected officials, to take a proactive and bold approach to envision, support and expand access to healthy foods for residents of all ages, abilities, and cultural and economic backgrounds.

As a result of our participation in the Food for All Broward Initiative and with Technical Assistance provided through it, the team defined (1) policy and/or (1) systems changes to support and expand healthy food access for all residents. These changes, next steps, and the timeline to implement the selected change(s) are outlined below. Supporting materials can be provided digitally.

This letter documents the intent and plan from the City's Green Team of the City of Coconut Creek in Florida to **implement these policy and systems changes:**

1. Policy Change: Pass a resolution to include language that links CO2 emission reduction, transit access and food access opportunities and strategies in City planning documents.

- a. Detail: The City of Coconut Creek will ensure CO2 emission reduction and food access are considered, with a common goal, in the City's Comprehensive Plan and/or other documents (e.g., Green Plan).
- b. Next Steps:
 - i. Final resolution completed by (date/month): 10/24/2019
 - ii. Final resolution approved by staff (date/month): 10/30/2019
 - iii. Final resolution passed at City Commission meeting on (date/month): 11/14/2019

2. Systems Change: Support the development of a community-led food access and environmental stewardship education component.

- a. Detail: The City of Coconut Creek will work with the Environmental Advisory Board to develop an education component on the connections between food access, environmental health, and community health and wellbeing that they will steward throughout the community.
- b. Next Steps:
 - i. Meeting with Environmental Advisory Board by (date/month): 11/19/2019
 - ii. Develop Educational Component by (date/month): 11/30/2019
