

RESOLUTION NO. 2017-190

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A SOLE SOURCE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND TRITECH SOFTWARE SYSTEMS, WHICH PROVIDES IQ SUBSCRIPTION SERVICE LICENSE FOR CRIMEVIEW DASHBOARD AND CRIMEMAPPING SOFTWARE; PROVIDING FOR AN INITIAL PURCHASE OF THE SUBSCRIPTION SERVICE LICENSE AND A TWO-YEAR RECURRING SUBSCRIPTION FEE, UTILIZING FEDERAL LAW ENFORCEMENT TRUST FUNDS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City and the Broward Sheriff's Office (BSO) will be entering into an interagency agreement to allow the City to have access to their law enforcement databases accessed through CrimeView Dashboard; and

WHEREAS, the City must purchase IQ Subscription Service License for CrimeView Dashboard and CrimeMapping software provided by Trittech Software Systems to be able to access BSO's databases; and

WHEREAS, the Agreement provides for the original purchase of the IQ Subscription Service License in the amount of \$50,775, which includes an automatic two-year recurring subscription fee, unless terminated; and

WHEREAS, the City has established a Federal Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to the Federal Department of Justice Agreement, and a Local Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to Section 932.7055, Florida Statutes; and

WHEREAS, the Chief of Police has requested that the City Commission make an appropriation from said funds; and

WHEREAS, the funds from the above request will be utilized for law enforcement purposes and complies with the requirements of the State of Florida Forfeiture Guidelines and/or the Department of Justice/Treasury Forfeiture Guidelines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2: That the City Commission hereby authorizes the City Manager, or designee, to execute the attached Agreement between the City and Trittech Software Systems, attached hereto and made a part hereof.

Section 3: That the City Commission hereby approves the appropriation of \$50,775 from the Federal Law Enforcement Trust Fund for IQ Subscription Service License for CrimeView Dashboard and CrimeMapping software.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
