CALL TO ORDER

Mayor Sarbone called the meeting to order at 7:03 p.m.

Mayor Sarbone explained that Governor Ron DeSantis' Executive Order 20-52, as continuously extended, and Section 252.38, Florida Statutes, authorized all local governments to waive procedures and formalities otherwise required by both state and local law as necessary to allow local governments to continue to perform public work and take whatever prudent action is necessary to ensure the health, safety, and welfare of the community. He noted that the meeting was being conducted live with a quorum physically present and participation by one (1) Commissioner using communications media technology consistent with the Governor's Order and State law. City Attorney Pyburn explained the procedures for public participation and comment for the meeting.

1. 21-058 ELECTION RESULTS – MARCH 9, 2021 MUNICIPAL ELECTION

Deputy City Clerk Bowers reported the receipt of the certified election results from the Broward County Supervisor of Elections for the March 9, 2021, Municipal Election. She read the detailed results into the record, which included Jacqueline Mary Railey winning the election for District B; Sandra L. (Sandy) Welch winning the election for District C; and Joshua David Rydell winning the election for District E.

2. 21-057 INVESTITURE OF ELECTED COMMISSIONERS FOR DISTRICTS B, C, AND E.

Judge John D. Fry of the 17th Judicial Circuit Court of Florida administered the Oath of Office to the newly elected and re-elected Commissioners.

Mayor Sarbone spoke about the impacts the City faced over the past year due to the state of emergency resulting from COVID-19 pandemic and shared some of the accomplishments of the Commission and staff in responding to the emergency conditions.
