CALL TO ORDER

Mayor Welch called the meeting to order at 7:00 p.m.

Mayor Welch asked all to rise for the Pledge of Allegiance.

PRESENTATION(S)

1. 19-132 A SWEARING-IN CEREMONY FOR NEW POLICE OFFICERS
ALEXANDER LUKIANOV AND EMMANUEL TORRES-CARRASQUILLO.

Police Captain Fred Hofer introduced Police Officers Alexander Lukianov and Emmanuel Torres-Carrasquillo and invited them and their families to come forward for the swearing-in. City Clerk May administered the Oath of Office followed by the badge-pinning ceremony.

2. 19-133 A PRESENTATION OF THE DISTINGUISHED BUDGET PRESENTATION AWARD FOR THE CITY'S FISCAL YEAR 2019 ANNUAL BUDGET AND FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM.

Finance and Administrative Services Deputy Director Peta-Gay Lake presented the item. She announced that Budget and Grants Manager Kisha Bolden was awarded a Certificate of Recognition for Budget Presentation, and thanked Ms. Bolden for her work. She thanked the Commission, Finance staff, and all City Departments for their assistance with the budget preparation. Deputy City Manager / CFO Brooks presented the award, and Ms. Bolden briefly addressed the Commission.

3. 19-130 A PROCLAMATION RECOGNIZING JULY 2019 AS "NATIONAL PARKS AND RECREATION MONTH."

Vice Mayor Sarbone read the proclamation into the record. Parks and Recreation Supervisor Amy Jean-Baptiste accepted the proclamation on behalf of the Parks and Recreation Department.

INPUT FROM RESIDENTS OF COCONUT CREEK

Kaniel Reuben, 4385 NW 45 Terrace, Coconut Creek, expressed his concerns about exiting the Coquina residential neighborhood and making a left-hand turn. He requested that a traffic signal be installed at the community entrance.

Annette Rose, 4402 NW 41 Place, Coconut Creek, stated that she was a board member for the Coquina Homeowner's Association. She was concerned with not having a traffic signal at the community entrance and commented that she had seen many accidents at that location. She also requested a pedestrian walkway for the students who cross the street at the Coquina entrance.

Howard Tafares, 4326 NW 42 Terrace, Coconut Creek, stated that he was a board member for the Coquina Homeowner's Association. He mentioned that there were a lot of accidents at the entrance to the community and that changing the traffic flow out of the community to a right turn only would not work. He spoke about speeding on Lyons Road and requested that a traffic signal be installed at the community entrance.

Istmenia Rader, 4365 NW 45 Terrace, Coconut Creek, stated that it was important to have a traffic signal installed at the Coquina community entrance for the safety of the community.

Stephanie Appert, 4282 NW 44 Terrace, Coconut Creek, spoke about the number of accidents on Lyons Road between Wiles Road and Cullum Road and relayed a recent incident of a motorcyclist who had been hit by a vehicle. She urged the Commission to take action, including a new traffic study, workshop to obtain resident input, better lighting, and a reduced speed limit in the area.

Assistant City Manager / Director of Sustainable Development Sheila Rose addressed the Commission and provided a brief history of the area, noting that the developer of Coquina was required to provide a bond for a quarter of the construction costs associated with installing a traffic signal and that the property owner across the street was responsible for the remaining costs. She noted that the section of Lyons Road was under Broward County's jurisdiction and that the City had been pursuing a signal with the County since 2015. She stated that the City conducted a traffic study in 2017 and that the results did not meet the County's criteria for installing a signal. Ms. Rose commented that she would meet with the residents to further explain the traffic signal thresholds.

CITY MANAGER REPORT

Deputy City Manager Brooks announced that she received the assessed property value report from the Broward County Property Appraiser and noted that she would forward the report to the Commission. She wished everyone a happy 4th of July.

CITY ATTORNEY REPORT

City Attorney Pyburn wished everyone a happy and safe 4th of July.

COMMISSION COMMUNICATIONS

Commissioner Rydell had no report.

Commissioner Tooley attended the swearing-in ceremony for newly-elected District 97 State Representative Dan Daley.

Commissioner Belvedere attended the World Refugee Day event at Broward College and spoke about the 145 attendees who became U.S. citizens.

Vice Mayor Sarbone attended the Broward League of Cities meeting where City Manager Blasi was honored as a 2019 Home Rule Hero. He asked about the status of the bike lanes delineators on Winston Park Boulevard, and Ms. Rose said that she would follow up with the Engineering Department. Vice Mayor Sarbone noted that he had seen an increase in truck traffic along Wiles Road and asked if traffic enforcement in the area was continuing. Deputy City Manager Brooks commented that enforcement was ongoing and provided a brief overview of the enforcement hours and citations issued. Vice Mayor Sarbone asked for a status on the installation of the traffic signal on Lyons Road at the Winston Park Shopping Plaza, and Deputy City Manager Brooks explained the delays with the project and unmarked utility lines that had been found during construction.

Mayor Welch mentioned that she received a letter from Kathleen Cannon of the United Way organization, congratulating the City for leading Broward County in the focus on physical, mental, and financial health issues. She visited the recycling center with Public Works Operations Manager Mike Heimbach and spoke about the contamination found in the recyclable materials. She suggested producing an educational video for the residents, showing the contamination and permissible recyclable materials. She mentioned that Broward County Sheriff Gregory Tony expressed interest in meeting with the City to discuss E911 dispatch services from the County. She noted that she did a ride-along with Senior Code Compliance Officer Briana Capone and commended her and the Code Enforcement Team for their efforts. Commissioner Rydell stated that he was not supportive of waiting for the County to make improvements to the regional dispatch communication system and was interested in continuing to pursue dispatch services with the City of Coral Springs. Commissioner Tooley was not in favor of staying with the County for dispatch services. Vice Mayor Sarbone discussed having an alternative available if an agreement with Coral Springs was not successful that would allow the City take over the operation of the dispatch center located in the City's Emergency Operations Center (EOC) building with City-employed supervisors and dispatchers. Consensus was given for City Manager Blasi to pursue the alternative option if necessary. Mayor Welch received consensus to provide a letter of support to the National Science Foundation (NSF) on behalf of Florida Atlantic University (FAU) and collaborating universities' grant application for Advancing Communications and Computing for Emerging StreetScapes (ACCESS) and a letter of support for the County's grant application to the Edward Byrne Memorial Justice Assistance Grant (JAG) program.

AN ORDINANCE AMENDING THE CITY'S CODE OF ORDINANCES, BY AMENDING CHAPTER 11, "FOOD AND FOOD ESTABLISHMENTS," BY ENACTING SECTION 11-2, "PROHIBITION ON THE DISTRIBUTION OR USE OF SINGLE-USE PLASTIC STRAWS," TO PROHIBIT THE DISTRIBUTION OR SALE OF SINGLE-USE PLASTIC STRAWS WITHIN THE CITY AND TO PROHIBIT THE USE OF THOSE ITEMS UPON CITY PROPERTY, WITHIN CITY FACILITIES, OR AT CITY-APPROVED SPECIAL EVENTS TO REDUCE WASTE AND PROTECT THE ENVIRONMENT; PROVIDING FOR PENALTIES. City Attorney Pyburn read the Ordinance title into the record.
