

**RESOLUTION NO. 2019-274**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED SCHOOL RESOURCE OFFICER (SRO) AGREEMENT BETWEEN THE SCHOOL BOARD OF BROWARD COUNTY AND THE CITY OF COCONUT CREEK FOR A PERIOD COMMENCING ON AUGUST 8, 2019, AND ENDING ON AUGUST 7, 2020; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the School Board of Broward County has established a School Resource Officer (SRO) Program pursuant to the Marjory Stoneman Douglas High School Public Safety Act; and

**WHEREAS**, the City of Coconut Creek and the School Board of Broward County agree that the SRO Program provides benefits to the school administration, students, and the community as a whole; and

**WHEREAS**, it is the desire of the City to provide police officers to serve as SROs for the benefit of the public schools located within the City; and

**WHEREAS**, the City and the School Board of Broward County previously signed a School Resource Officer Agreement for the 2018-2019 School Year; and

**WHEREAS**, the City and the School Board of Broward County have agreed that the School Board will provide \$65,520 monthly to the City for twelve (12) SROs during the ten (10) month term of the agreement from August 8, 2019, through June 3, 2020, for the sum of \$655,200. Additionally, the City will receive two installments of \$10,920 for June 2020 and July 2020 to have one (1) SRO assigned to Atlantic Technical College and one (1) SRO assigned to Dave Thomas Educational Center West for those months, bringing the total to \$677,040 from the School Board to cover the year-round SROs assigned to those two schools.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached agreement between the City and the School Board of Broward County.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said agreement by and between the City of Coconut Creek and the School Board of Broward County, attached hereto and made a part hereof.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
