

RESOLUTION NO. 2020-111

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ACCEPTING A SCHOOL SAFETY GRANT IN THE AMOUNT OF \$40,000; AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED END USER AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND SCHOOL SAFETY GRANT, LLC FOR THE USE OF SCHOOL SAFETY GRANT SOFTWARE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek applied for the School Safety Grant and was one of the organizations selected; and

WHEREAS, the grant provides \$40,000 to purchase the Alert System software, which allows police personnel access to the other organizations that were awarded the grant; and

WHEREAS, by entering into this agreement, police personnel will have access to the Alert System software, which provides real time (live) video feeds from public schools, private schools, charter schools, houses of worship, and meeting places that applied for and have been awarded this grant; and

WHEREAS, police will also have access to the electronic locks and public address (PA) systems of the participating organizations; and

WHEREAS, it is the desire of the City to provide every possible means of protection for the benefit of all the organizations who have received the School Safety Grant and are part of the program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission hereby accepts the School Safety Grant in the amount of \$40,000.

Section 3: That the City Commission has reviewed and hereby approves the attached agreement between the City and School Safety Grant, LLC for the purpose of protecting the students and citizens of Coconut Creek.

Section 4: That the City Manager, or designee, is hereby authorized to execute said agreement between the City and School Safety Grant, LLC, attached hereto and made a part hereof.

Section 5: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
