Police Chief Mann presented a summary of each of the new police officers and noted that their families were in the audience.

The new Police Officers were sworn into office by the City Clerk.

Police Officer Christopher Lewis surprised his family by proposing marriage to his girlfriend. The proposal was happily accepted.

#### **CITY MANAGER REPORT**

City Manager Blasi announced that the Broward County Commission meeting regarding the closure of the Wheelabrator plant scheduled for January 13 has been rescheduled to either February 3 or February 10, 2015. She would keep everyone posted of the new meeting date once confirmation was received.

### CITY ATTORNEY REPORT

City Attorney Terrill Pyburn wished all a Happy New Year.

#### **COMMISSION COMMUNICATIONS**

Commissioner Welch reported receiving very positive feedback from residents regarding the painted crosswalks on Coconut Creek Parkway. She noted that recently there have been several articles about the migrating Monarch butterflies' need for more native milkweed plants. She asked City Manager Blasi to arrange for distribution of native milkweed seeds to increase the plants within the City. She attended the ribbon cutting at *All Star Recruiting* and remarked that the owners are very engaged in the community. She also met with Monarch High School students to acquire scholarship applications for the Broward League of Cities scholarship program.

Commissioner Belvedere attended a candle lighting ceremony for Hanukah at the Promenade. She attended a special meeting of the Metropolitan Planning Organization (MPO) where the main discussion was transportation issues through 2040. She explained that the focus should be on continuity; for example, bicycle lanes in the City should be extended into neighboring cities. She said another MPO focus was more education to the residents regarding MPO goals and activities, as the organization provides funds for many projects. Commissioner Belvedere noted that there were three Broward County Commissioners present at the MPO meeting as well as a Commissioner from the City of Deerfield Beach. She was surprised at how little they were aware of the issues with Wheelabrator when she spoke with some of them. City Manager Blasi suggested sending letters to the elected officials of the City of Pompano Beach and the City of Deerfield Beach to bring more awareness of the matter.

Commissioner Sarbone complimented the Police Department on the great work they do each day. He announced that there would be boys Basketball on Saturday morning. He also noted the grand opening of Planet Fitness on January 24, 2015. At his inquiry, City Manager Blasi advised that the City's new movie theater may be open in April, 2015.

Mayor Tooley said she received a tour of the new theater, which she found to be much larger than she anticipated. She attended a lecture at Broward College presented by the Deputy

Secretary of Energy. She noted that she would leave blue outdoor lights on at her house in support of Law Enforcement.
