

**RESOLUTION NO. 2020-080**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING FIVE (5) REGULAR MEMBERS AND ONE (1) ALTERNATE MEMBER TO THE COMMUNITY OUTREACH ADVISORY BOARD, PURSUANT TO SECTIONS 2-191, "AUTHORITY OF CITY COMMISSION TO APPOINT BOARD MEMBERS; TERM OF OFFICE OF BOARD MEMBERS" AND 2-266, "MEMBERSHIP" OF THE CITY'S CODE OF ORDINANCES FOR A TERM ENDING WITH THE NEXT APPOINTMENT IN 2021; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with Section 2-191(b) of the City's Code of Ordinances, the City Commission shall appoint board members at the second regularly-scheduled Commission meeting each April; and

**WHEREAS**, in accordance with Section 2-266 of the City's Code of Ordinances, the City Commission shall nominate one (1) person to fill each position on the Community Outreach Advisory Board, and one (1) alternate member of the Board shall be selected by the Mayor. A majority of the Commission shall approve the nominations.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the City Commission hereby nominates the following five (5) individuals as regular members of the Community Outreach Advisory Board, pursuant to Section 2-266, Code of Ordinances, for a term ending with the next appointment in 2021:

Tooley: Kathy McCombs  
Belvedere: Jacqueline Railey  
Welch: Whitney Larmond


**Section 2:** That the following individual is nominated by the Mayor as the alternate member of the Community Outreach Advisory Board, pursuant to Section 2-266, Code of Ordinances, for a term ending with the next appointment in 2021:

Alternate: Cheryl Higgins


**Section 3:** That the individuals set forth in Sections 1 and 2 above are hereby appointed to membership on the Community Outreach Advisory Board.
