

**RESOLUTION NO. 2021-214**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND PLAYCORE WISCONSIN, INC. D/B/A GAMETIME FOR THE COCO POINT PARK AND LAKEWOOD PARK PLAYGROUND ADA IMPROVEMENTS AND CONSTRUCTION PURSUANT TO RFP NO. 07-28-21-11 IN THE AMOUNT OF \$379,134.15; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, according to industry standards, a playground's lifespan is approximately 15 years, and the Coco Point Park and Lakewood Park playgrounds were constructed approximately 20 years ago; and

**WHEREAS**, the project consists of removing existing playgrounds that are in poor condition and replacing them with new themed playgrounds; and

**WHEREAS**, the City issued 315 electronic invitations, of which there were three responsive submittals. A selection committee, consisting of Wayne Tobey (Parks and Recreation Director), Scott Stoudenmire (Director of Sustainable Development), Lou Italico (Project Manager), and Daniel Nelson (Community Enhancement Manager), ranked the top three companies based on the RFP criteria. The final ranking resulted in the following shortlist order: 1) Playcore Wisconsin, Inc. d/b/a GameTime, 2) Bliss Products and Services, Inc., and 3) KorKat; and

**WHEREAS**, the negotiation committee, made up of the aforementioned staff members, negotiated an agreement for the parks improvements with Playcore Wisconsin, Inc. d/b/a GameTime in the amount of \$379,134.15; and

**WHEREAS**, the Purchasing Division reviewed the RFP responses for compliance and no issues were found; and

**WHEREAS**, project completion time shall be 180 calendar days from the issuance of the Notice to Proceed; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with Playcore Wisconsin, Inc. d/b/a GameTime to provide for the Coco Point Park and Lakewood Park playground ADA improvements and construction pursuant to RFP No. 07-28-21-11.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the agreement, attached hereto and incorporated herein as Exhibit “A,” between the City of Coconut Creek and Playcore Wisconsin, Inc. d/b/a GameTime for the Coco Point Park and Lakewood Park playground ADA improvements and construction in the amount of \$379,134.15.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and Playcore Wisconsin, Inc. d/b/a GameTime and any change orders in accordance with the Purchasing Policies & Procedures Manual.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
